The Greene Library Board met in regular session on Monday, May 11, 2026 at 5:00 pm in the library. Present were Barbara Brunsmma, presiding, board members Andrea Ramker, Daniel Castle, Kathi Stuntz, Ann Thomason, and Patrick Derdzinski. Library Director Lyndsie Pitzenberger and visitor Jose Reyes of Siblings Roofing were also in attendance.

Motion by Andrea Ramker, second by Ann Thomason to approve and amend the May 11, 2026 agenda moving item 6, Visitor's Comment, to item 2 and approve April 2, 2026 minutes. Roll call, all ayes. Motion carried.

Visitor Comments: Jose Reyes, representative from Sibling Roofing of Belmond, IA was present to discuss roofing damage and asked the board if they could make a free inspection of the library roof for damages caused by a recent hail storm. 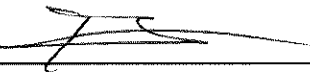
